
Terms and Conditions – Interior Fittings Introductory Offer

1. Definitions

For the purposes of these Terms and Conditions:

- **“Promotion”** means the Interior Fittings Introductory Offer as described herein.
- **“Eligible Products”** means only the products specified in Clause 4 below.
- **“Customer”** means the purchaser of the Eligible Products under this Promotion.
- **“Promotional Period”** means the time from the launch of the Promotion until 18 December 2025, unless withdrawn earlier in accordance with Clause 8.

2. Eligibility

2.1 The Promotion is open to all customers purchasing Eligible Products directly from Hettich New Zealand within its sales territories.

2.2 The Promotion is subject to these Terms and Conditions and is void where prohibited by law.

3. Promotional Offer

3.1 During the Promotional Period, Customers may purchase the Eligible Products together as a bundle for the promotional price of NZD \$500 (excluding GST).

3.2 The promotional price applies only when the Eligible Products are purchased together in a single order placed via email through a Hettich Territory Manager or Customer Service team member.

4. Eligible Products and Bundle Inclusions

4.1 The Promotion applies exclusively to the following products, as pictured in promotional materials:

- (a) One (1) 450mm Width Corner Unit, Shelf Style 200, Anthracite + Anti Slip Mat; and
- (b) One (1) 150mm Width Lario, Shelf Style 200, Anthracite + 470mm Quadro Runner Set.

4.2 The Promotion expressly excludes the Senio range.

4.3 No substitutions, alterations, or product variations are permitted under the Promotion.

5. Exclusions

5.1 The Promotion cannot be used in conjunction with any other promotion.

5.2 The Promotion does not apply to products not expressly listed in Clause 4.

6. Orders and Payment

6.1 All orders are subject to Hettich’s standard terms of trade.

6.2 Pricing is exclusive of GST and excludes delivery and installation charges unless otherwise stated.

6.3 Full payment terms apply as per Hettich’s standard account conditions.

7. Delivery

7.1 Delivery times may vary depending on stock availability and location.

7.2 Hettich will not be liable for any delay or failure to deliver the Eligible Products within any stated timeframe.



8. Stock Availability and Right to Withdraw

8.1 The Promotion is strictly subject to stock availability.

8.2 Hettich reserves the right to:

(a) withdraw, suspend, or amend the Promotion at any time without prior notice if stock is exhausted; and/or

(b) substitute equivalent products of equal or greater value if required due to stock shortages, in agreement with the purchaser.

9. Liability

9.1 To the maximum extent permitted by law, Hettich will not be liable for any loss, damage, cost, or expense arising from or in connection with the Promotion, including any withdrawal or amendment in accordance with Clause 8.

9.2 These Terms and Conditions do not exclude or limit any rights or remedies under the New Zealand Consumer Guarantees Act 1993 that cannot be excluded or limited by law.

10. General

10.1 Hettich reserves the right to verify the eligibility of any order under the Promotion.

10.2 Errors and omissions excepted (“E&OE”).

10.3 These Terms and Conditions are governed by the laws of New Zealand and the parties submit to the non-exclusive jurisdiction of the New Zealand courts.
